**RESOLUTION NO. 24-051**

**RECOGNIZING DECEMBER 1, 2024, AS WORLD AIDS DAY**

*WHEREAS, World AIDS Day is recognized on December 1<sup>st</sup> every year to raise awareness of the AIDS pandemic and to mourn those who have died from the disease; and*

*WHEREAS, Human Immunodeficiency Virus (HIV) is the virus that causes AIDS (Acquired Immunodeficiency Syndrome). HIV attacks the immune system, and unlike many other viruses, the body cannot rid itself of HIV; and*

*WHEREAS, worldwide in 2023, 1.3 million people were newly infected with HIV, 39.9 million people were living with HIV and 630,000 people died of AIDS-related illnesses—one person every minute; and*

*WHEREAS, the U.S. theme for 2024 is “Collective Action: Sustain and Accelerated HIV Progress” encapsulating the government’s dedication to harnessing the significant progress that has been made through global and domestic HIV programs over the last four-plus decades and without an acceleration of collective efforts and resources, the gains in the HIV response will be jeopardized; and*

*WHEREAS, the Snohomish County Health Department provides education and prevention programs to help residents understand and reduce risks of getting HIV, including confidential and anonymous HIV testing; and*


*WHEREAS, populations disproportionately affected by HIV are also often affected by stigma due to, among other things, their gender, sexual orientation, gender identity, race/ethnicity, drug use, or sex work. HIV stigma drives acts of discrimination in all sectors of society, including health care, education, the workplace, the justice system, families, and communities; and*


*WHEREAS, HIV remains an urgent health issue that starts with listening and centering those with HIV. The current global health goal is to end AIDS as a public health threat by 2030; and*

*WHEREAS, the most recent data from 2023 reported 29 new HIV cases in Snohomish County and 1,340 people were living with HIV/AIDS in Snohomish County;*


**NOW, THEREFORE, BE IT RESOLVED**, that the Snohomish County Council recognizes December 1, 2024, as World AIDS Day in Snohomish County.
